Re: Adjudication Order No. EAD-7/BD/NR/2019-20/7086
Order dated February 28, 2020 (“**AO Order**”) passed in the matter of non-compliance of SEBI Order dated March 19, 2014 by Financial Technologies (India) Ltd., presently known as 63 Moons Technologies Ltd.) (received by us on March 06, 2020).

We refer to the AO Order passed in connection with the Show Cause Notice, dated January 28, 2015 bearing reference No. EAD/PJ/VRP/3097/2015 (“**SCN**”) issued to Financial Technologies (India) Ltd., presently known as 63 Moons Technologies Ltd.) (“**Noticee**”).

The SCN was issued for alleged non-compliance with the SEBI Order March 19, 2014 (“**SEBI Order**”). The SEBI Order is based on the Forward Markets Commission’s order dated December 17, 2013, which is presently pending challenge before the Hon’ble Bombay High Court in Writ Petition No. 337 of 2014. The reasons for delay in compliance with SEBI Order being *bona-fide* and beyond the Noticee’s control, were explained to SEBI. The Noticee disagrees with the need to impose any penalty under Section 23H of SCRA on account of delay in compliance with SEBI Order. Yet the A.O. Order came to be passed.
