We wish to inform you that, SEBI vide its above referred circular and various circulars issued from time to time in this regard, had prescribed simplified norms for processing Investor Service Requests (ISR) by the Registrar and Share Transfer Agent (RTA) and norms for furnishing of PAN, KYC details and Choice of Nomination details by holders of securities in physical form.

Shareholders holding shares in physical form, whose folio(s) do not have PAN, KYC details (Postal Address with PIN, Mobile Number, Email Address, Bank Account Details and Specimen Signature), shall be eligible:

- a) to lodge grievances or avail any ISR only after the aforesaid details are furnished to the RTA.
